Public Input Session Minutes - Ward 6 Revised minutes of the 2007 Budget Public Input and Information

Session of the City of Greater Sudbury - Ward 6 was tabled.

## PRESENTATIONS/DELEGATIONS

Item 2 2007 Winter Maintenance Mr. Greg Clausen, Acting General Manager of Infrastructure provided an electronic presentation entitled "Winter Operations Budget 2007" which briefly outlined the background for minimum maintenance standards. He advised that the options being presented will be implemented in November 2007.

Mr. Bob Falcioni, Director of Roads & Transportation, provided information on the current service level performed by winter maintenance crews and comparisons to northern municipalities.

Mr. Clive Wood, Manager of Operations, provided five options:

**Option 1:** Reduce contracted services by 50% - estimated savings \$1.374 million

**Option 2:** City coverage sixteen hours - estimated savings \$746,000

**Option 3:** Bare pavement to snow-packed - estimated savings \$614,000

**Option 4:** Reduce staff positions - estimated savings \$200,000

**Option 5:** Shorter standby season - estimated savings \$81,000

Mr. Wood advised that these options would require discussions and co-operative working partnerships with the CUPE Locals and contractors.

Mr. Falcioni advised that staff was proposing an additional option entitled Customer Service Enhancement. He advised that this would provide public access to a Global Positioning System (GPS) on the City's web site to track real-time progress of winter control units. The installation of video cameras at strategic locations on local roads would provide public access to video surveillance and a Winter Control Centre would improve efficiency of winter roads operations through one centralized GPS tracking station. Mr. Falcioni indicated that this would cost approximately \$200,000.

Councillor Dupuis requested that Senior staff meet with Winter Maintenance employees to obtain their input and how the system works. He also requested that staff provide Council with a list of streets that would be affected by Option 3.

## Report Requested

The Acting General Manager of Infrastructure volunteered to get back into discussions with unions, former employees, etc and report back in June in an attempt to reduce the budget but still provide the same level of service.

Option 1 - Winter Roads Maintenance Option 1 - Winter Roads Maintenance 2006-06-28 (continued) Councillor Caldarelli stated that some of the rural roads should be plowed earlier than some residential roads because of the distance from a major arterial road, and requested that staff review the service levels provided to the rural and residential areas.

With the consensus of the Committee, staff was directed to review Option 1 and bring back a report with further information on the type of service that could be provided which meets legislated responsibilities and provides winter road maintenance to the satisfaction of the citizens. The review should include Councillor Caldarelli's suggestion to review the service levels to rural and residential areas.
